Terms & Conditions:

- 1. Application fee includes Information packet fee and Registration fee.
- 2. The group of farmers shall consist of minimum 25 and maximum 500 Farmers. More than 500 numbers of farmer will consider in another group and the charges will be considered.
- 3. Additional taxes and duties will be charged as per Govt. Regulations.
- 4. One man-day is of 8 hours.
- 5. An Advance payment of 50% of the estimated cost is necessary before the inspection or at the time of application / registration. Balance (including Lab fee) is to be paid before the dispatch of scope certificate, on the basis of the detailed invoice with the actual cost.
- 6. The fee paid is not refundable in any circumstances.
- 7. The payment of the said fees itself shall not *ipso facto* entitle the grant of certification to the operator / client, decision on the grant of certificate shall be independent of the payment of the fees.
- 8. Based on the above-mentioned fee, a detailed estimated of the overall cost will be prepared for each inspection. The operator / client is requested to give a written confirmation of acceptance of the cost.
- 9. Travel expenses include boarding, lodging, Food, and local conveyance charges.
- 10. Above mentioned fee structure may get change from time to time, as per whole and sole discretion of the AGROCERT.
- 11. Renewal fee will be charged @ 50% of the application (registration) fee whereas other component will be according to the fee structure provided by the AGROCERT.
